DECLARATION OF MONICA L. REBUCK IN SUPPORT OF PLAINTIFFS' MOTION FOR REIMBURSEMENT OF EXPENSES AND CREATION OF A FUND FOR FUTURE LITIGATION EXPENSES

- I, Monica L. Rebuck, declare as follows:
- 1. I am a shareholder at the law firm of Hangley Aronchick Segal Pudlin & Schiller. I submit this Declaration in support of Plaintiffs' Motion for Reimbursement of Expenses in connection with services rendered in prosecuting this action through trial.
- 2. My firm has acted as counsel to two of the Individual Plaintiffs, Rite Aid and CVS, throughout this litigation. Individual Plaintiffs opted out of the Direct Purchaser Class, and their attorney fees and expenses are not subject to court approval. I submit this declaration in connection with the Court's approval of the class settlements to identify the Individual Plaintiffs' portion of the Teva settlement fund.
- 3. In accordance with the settlement agreement negotiated with Teva, all Plaintiffs including Individual Plaintiffs will be reimbursed their costs and expenses out of the Teva settlement fund. After reimbursement of all costs and expenses and a lump sum payment to the End Payor class, Individual Plaintiffs will receive 39% of the remainder of the settlement fund. As opt-outs, Individual Plaintiffs will have no claims against the remaining portion of the settlement fund.

4. On behalf of its clients CVS and Rite Aid, this firm has incurred a total of \$878,212.73 in expenses in connection with the prosecution of this litigation through the end of trial, including return travel from trial. These expenses are summarized as follows:
