**Declaration of Matthew P. McCahill in Support of

Matthew P. McCahill, subject to the penalties of perjury provided by 28 U.S.C. § 1746, does hereby declare as follows:

1. I am a partner in the law firm of Kaplan Fox & Kilsheimer, LLP, attorneys for the Direct Purchaser Class Plaintiffs and co-counsel for Named Plaintiff FWK Holdings, LLC (“FWK”) in the above-captioned case. I submit this declaration in support of Direct Purchaser Plaintiffs’ Motion for Attorneys’ Fees, Reimbursement of Expenses, and Incentive Awards for the Named Plaintiffs.

2. During this litigation my firm has been involved in various activities on behalf of both our client FWK and the Direct Purchaser Class. Chief among those activities were:

- Investigating the case and preparing the *FWK* complaint, and helping to prepare the Direct Purchaser Plaintiffs’ Consolidated Amended Class Action Complaint;
- Researching and drafting sections of Plaintiffs’ class certification papers and Plaintiffs’ opposition to Defendants’ motion to dismiss;
